CENTRAL COMMITTEE MEETING (EXTENDED) HELD ONLINE ON 16TH JUNE 2026

FOUNDATION DAY (24TH JUNE) TO BE CELEBRATED AWARENESS CAMPAIGN TO BE LAUNCHED

The 39th Meeting of Central Committee of CBSPRA was held online through zoom VC on 16th of June 2026. The participation was extended to all the Circle Secretaries. The meeting was presided over by Com. C Gangadhar Yadav, Chairman, who also hosted the zoom VC. Com. R K Sharma, President and Com K Suresh Babu, General Secretary were present. The meeting was attended by Circle Secretaries from various parts of the country apart from the Central Committee.

At the outset, homage was paid to the departed souls of comrades - leaders and members who passed away during the interregnum by observing two minutes silence in their memory.

The Chairman after confirming the quorum and calling the house to attention, commenced the proceedings by explaining the context of the meeting and outlining the scope of discussion to be held. The President making his welcome remarks emphasized on the need to strengthen the organisation at the grass root level.

The General Secretary welcomed the participants and placed before the House a review of important developments relating to retirees' issues, organisational activities and the present status of various matters being pursued by the Association at Bank level through periodical visits to and meetings held at HO as well as at industry level through AIBPARC action programmes.

The House reviewed the progress made by the Association during the recent period and noted with satisfaction the continued growth and strengthening of the organisation. The members appreciated the wholehearted support extended by retirees across the country, resulting in CBSPRA emerging as one of the largest and most vibrant retirees' organisations in the banking industry.

The House also reviewed the developments in respect of pending retirees' issues and the discussions held with the Management through the Grievance Redressal Committee mechanism. It was noted with satisfaction that regular interaction with the Management has helped in creating a congenial atmosphere for discussion of retirees' concerns and resolving several issues.

The meeting was held on the eve of our beloved Association CBSPRA's 14th Foundation Day, the participants fondly recalled the journey of the organisation since its inception and paid rich tributes to all the founders, leaders, office bearers and members who have contributed to its growth and success over the years. The House noted with pride that the Association has successfully completed fourteen years of glorious existence and dedicated service to retirees and entered its fifteenth year with membership enrolment crossing 17,000-mark.

- iii. To call on all the Heads of Regional Offices, Circle Offices and MD and CGM HR at HO of the Bank in person by all the locally available Central Office bearers and Zonal/Circle/Regional leaders and to submit a common memorandum on urgent issues.

All Zonal and Circle functionaries assured the House that they would make the Foundation Day Programme a grand success and continue their efforts to strengthen the organisation and effectively pursue the cause of retirees. The meeting concluded with a vote of thanks by Com R Adishesu Babu, CC Member.
