Sub: Sending of on- line memorandum by all the members of our affiliates, Constituents of CBPRO and also by other willing Retirees to the Hon'ble Union Finance Minister, the Secretary, DFS, MOF and the Chairman, IBA on the long pending demands of Bank Retirees including the most important one -- updation of pension.

1. Members are aware of the fact that this is the second phase of our agitational programme as decided and declared by earlier communications of AIBPARC. We are advising hereunder the detailed procedure of how to participate in the on - line memorandum which in recent days is considered as one of the most powerful tools to ventilate the grievances before the authorities concerned. The campaign will remain open upto 31st December, 2023 if otherwise not decided by the organisation.

2. Members are also aware of the fact that similar such campaign was initiated by our organization in the years 2020 and 2022. The success was ever- growing in nature. We also believe that this time, the number of mails would surpass all previous records since the atmosphere is super charged with anger and emotion. It is the need of the hour that individual member should convey his/ her views to the decision making authorities.

3. Members are first to open our website: www.aibprc.co.in. Just above the photographs of the President and the General Secretary, there is a rectangular Box of red colour in which it is written: "Updation of Pension and other issues of Retirees ". Click is to be made on this box.

*A page containing the Memorandum will open up. At the bottom of the letter, three (3) boxes will be seen. The participating member will write his/ her full name, mobile number and email id in separate boxes.

*Then a click is to be made on the "confirm" button. The mails will automatically trigger and a confirmation copy will come to the Sender. From our previous experience, we have seen that whenever there is congestion in the line, the return mail may not always come.

* We have a large number of members and well wishers. In the first few days, many members will make an attempt to send the memorandum at a time. There might be initial problems in sending. Please do not worry about it. Whatever response comes to the members, the same may be conveyed to the GS so that he can take up with the web manager for resolve.

4. All our affiliates are earnestly requested to employ their fullest endeavour to ensure that members in largest number possible can take part in the campaign. Our relentless struggle for achieving the long pending demands will continue. On successful completion of this phase, the Governing Council will take stock of events and decide further course of action.
