**CENTRAL COMMITTEE MEETING**  
**HELD ON 27<sup>th</sup> APRIL 2026**

The 38th Meeting of the Central Committee of CBSPra was held on 27th April 2026 at Ernakulam on the eve of General Body Meeting of AIBPARC scheduled on 28<sup>th</sup> and 29<sup>th</sup> of April 2026. The meeting was conducted in hybrid mode, with members attending physically as well as virtually i.e. online through Zoom Video Conference.

The meeting was presided over by Com. C. Gangadhar Yadav, Chairman of CBSPra, who also hosted the zoom VC. Com. R. K. Sharma, President, was present physically, while Com. K. Suresh Babu, General Secretary participated virtually.

At the outset the Central Committee paid homage to the departed souls during the interregnum by observing two minutes of silence. Thereafter the house considered the agenda led by the General Secretary Viz. Approval of minutes of the previous CC meeting, Accounts, members grievances etc.

Then the Committee discussed reports from zones on various activities undertaken in the zones including membership mobilisation drive. Focus was laid on pending grievances of members across the country to be taken/followed up with the management. Latest developments in pension updation case in Supreme Court and Plan-B proposed by AIBPARC i.e. Action Programmes, in case the Supreme Court case goes against retirees; Special Allowance cases in courts, Medical insurance related issues and other pending demands of bank retirees' were discussed.

Then the house considered the matter of participation and role and responsibility of CBSPra in the General Body of AIBPARC and finalised the names of office-bearers to be nominated for election to the Governing Council of AIBPARC. We are awaiting receipt of communication from the AIBPARC for final list of elected office bearers.

Thereafter, the committee took up Cooptions to fill vacancies, caused by resignations, in Central Committee and Zonal Committees of CBSPRA by co-option. The committee also considered request of certain zones to increase number of CC members commensurate with the growth of membership in their zones. The lists of Cooptions and nominated CC members are given below.
